Dear all,

You are two Venerable Academics from 2 different departments of UT, here CCi due to extreme sensitivity of the questions that I am raising.

One of you, is the seminal specialist of the subject this [article](#) and **you should worry why the authors knew, and had access to this one, but have manifestly boycotted it, yet, they have Acknowledged A. Daoud-Aladine in their work...?**

**These authors failed to test the exchange model that A. Daoud-Aladine is proposing in it, re-adapting the Zener Polaron model**, to the GKA approach to magnetic exchange.

**None of the exchange models these authors tested, has the right symmetry constraints of the ZPO structure**, the problematic of charge ordering is ignored, and the paper subsequently makes all along conceptual mistakes antagonising the ZP model, and promoting the "Goodenough model" instead, which hinders the fact they despise and misunderstand deeply how GKA rules have been set, and how they should be applied. What they advocate, is an antagonist view point to Goodenough Approach: the fashionable, topological insulator view point, of a ground state without charge order coming out from the DDDEX TOY MODELS!

**It is the proof that STFC censors the ILL forever on this matter, which constitute a fraud against the ORNL/SNS where Perring's INS data were collected and staff involved (Douglas Albernathy!)**

And **THE TWINNING ISSUE** (Flash Back 3, on Andrew Taylor final implication/ »censorship » by intimidation) is just the top of the Iceberg : even if TWINS have been correctly treated, **the other Link** (Flash Back1 and 2 regarding Prof TG Perring Scientific management from 2008) part of the full allegation Prof Chapon received, **demonstrate the Article is conceptually wrong and fraudulent** for many other reasons (almost every line of the paper is disputable!) because it roots in a management mistake made mid 2008 – coincident with the start of private/work strongly correlated Love affairs managed by a Group of complices including Champion...
